Booking Information

The registration fee includes attendance to all technical sessions, networking lunches and refreshments for the duration of the conference, drinks reception, and one place at the conference dinner (additional tickets are required for guests). A number of discounted rates are available to support authors, students and new graduates to attend.

Presenting authors are eligible for a 25% discount, up to a maximum of one author per paper.

Terms and Conditions

Payments

Full payment should accompany your booking. Fees must be paid in full no later than 14 working days before the event commences. All bookings made less than 14 days prior to the conference must be paid in full to guarantee registration. Once payment has been received, an email confirmation will be sent. If payment is not made at the time of booking, registration will be provisional. Failure to pay may result in attendance being refused.

Early Bird Rate

In order to qualify for any 'early bird' rates, booking and payment must be received before the deadline date listed.

Substitutions & Cancellations

Delegates may nominate an alternative person from their organisation to attend up to 24 hours prior to the start of the event, at no extra charge. Should substitution not be possible, cancellation charges apply as follows:

- From booking time to up to 21 days prior to the conference day will be subject to a € 50 administration fee.
- No refunds will be given for cancellations made less than 21 days prior to the conference.
